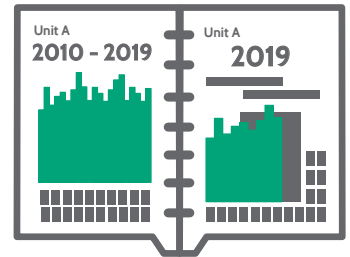

The Authors:

- transfer ownership of the supplied hard copy GSD; and
- provide a worldwide, perpetual, non-exclusive, non-transferable licence to the electronic copy of the GSD, to the Customer for the purposes of the Customer's reference and internal use in their business or undertaking.
